## **BUILDING PERMIT APPLICATION-600**

This form contains information/application for new construction, renovations, additions and electrical and plumbing upgrades.

The application needs to be completed with as much information as possible and will be reviewed by the Building Inspector and Public Works Department.

**Water and Sewer Taps:** If a water and sewer tap is required it is the responsibility of the owner/contractor to have the Mains exposed at the tap location and a trench dug to the meter site and/or sewer lateral. Trenches are to meet OSHA standards. Applicant will reply with all requests for the City of Bowling Green to ensure safe and prompt completion of the project.

**Water Tap Fee:** <sup>3</sup>/<sub>4</sub> inch \$920.67, 1 inch \$1,418.43, 1 <sup>1</sup>/<sub>2</sub> inch \$2,800.67, and 2-inch \$3,075.41 as of 2/14/22. The City will supply a maximum of 40 feet of K Copper, one tapping saddle, one curb stop, one-meter setter and one pit, ring and lid.

**Sewer Tap Fee:** 4 inch \$150.00, 6 inch \$175.00. The City will supply one tapping saddle and tap. Existing lines will be inspected by the Public Works Department to determine if they are properly installed and all Municipal and ICC Codes are followed.

**Excavation in City Street or Right of Way:** An Excavation Bond (\$500) is required of excavation is needed in a City Street or Right of Way.

**Storm Water:** A Storm Water Fee will be charged based on type of construction and land square footage. R1 and R2 land square feet is multiplied by .004. R3, R4, Commercial and Industrial land square feet is multiplied by .006. A Storm Water Plan by a Professional Engineer may be required.

**Building Permit Fee:** R1 and R2 estimated cost of construction is multiplied by .0032. R3, R4, Commercial and Industrial estimated cost is multiplied by .0039.
